1. Cover Letter

This is an independent internal review which is carried out by the Director Governance office on the actual ICAP result **(CAF-Sept-2021)**, RAR CAMPUS which was declared on 9th Nov 2021 for the session Sep,2021 by the ICAP.

2. Basis of the Report:

Basis of Assumptions:

- 1) Current assignment is to carry out review and comments on the ICAP actual (CAF Sep-2021) result compiled by the CA-Exam Department (RAR- Campus).
- 2) No verification could be carried out (due to non-availability of proper references regarding the tables of data-base and scope of work).

3. The purpose of this review is to achieve the following objectives:

- **Timeliness:** regarding compilation of ICAP Result (in Data-base) entries were made after 8 days of ICAP results (17-11-2021 to 24-11-2021) as referred Date of submitted in data-base and other faculty members may be followed the same practice. Whereas as per policy /sops it must be done on the same day or within maxi 2 days. Not only this but also, submission of "The Content Report" on ICAP Result (CAF RAR) was not made on time. It was submitted by the Exam department dated 29-11-2021 whereas as per policy it must be submitted within 7-10 days OR as per new directives (Sir Sadiq), in case of RAR result review it must be submitted within 2-3 days (Ref: The Content Report June 2021 RAR AFC Remarks by "Sir Sadiq")
- **Transparency:** it is a system-based actual ICAP result which shows high level of transparency.
- **Comparability:** Not yet applicable on similar scale. But It can be compared with March 2021 CAF result.
- Verifiability: 100% variables can be verifiable.

4. Executive Summary:

This session sept-2021 CAF RAR total papers were appeared in the strength report 853(Last session March 2021-902 Papers) in numbers. Out of which 64 papers were adjusted on account of Freeze-drop cases. The above mentioned adjustment was made after the CAF mar-2021 result as per policy with the prior approval of FD. 789 papers were shown in the data-base as output but due to ICAP allowed exemption in ITA and IEF net papers which have been accounted for the result are 462 in total.

Six (6) variables are identified, which is less than from last session. In last session there were ten (10) variables. Number of bad variables are seven (7) (Other than Pass and fail) out of which four (4) are uncontrollable and three (3) are adjustable variables.

There is one Merit of Certificate in IEF. Teacher name is Miss Mehwish Raja.

Overall Pass result is 25% and excluding ITA and IEF it is 36% (last Session 24%).

As compared to last session result:

- There is a direct reduction of 9% in Controllable variables (Invalid CRN, Password changed, Result Not Found and GHOST).
- There is a favorable decrease of 14 % in Zero-Attempt in ICAP Variable.

Overall Fail result is 21% (last session :33%) and excluding ITA and IEF it is 36%.

As compared to last session result:

- 38% increase in ICAP exemption variable due to transition.
- Post Result drop variable has unfavorable increase of 3%.

There in Non-Compliance of LP Hours. (Approved 100 hours)

Unstructured/Unplanned Manual CAF Testing was performed.
