STUDENTS PERFORMANCE REWARD POLICY

SCOPE AND PURPOSE:

This policy is intended to encourage and support high performing and talented students at SKANS School of Accountancy. From 1st April 2023, high performing and more able students will also be eligible for a discount in their subsequent CBE /Tuition Fee. These discounts are available to both SKANS's as well as outside students who wish to pursue their studies with the SKANS School of Accountancy provided the following criteria are met. For determining the discount eligibility, teachers and students must get their Course and examination time line entered into the SKANS Portal at the start of orientation class.

Students who are going to attempt the papers as set by the management time line but secure less than 90% Marks in their Examination, they will get the Discount in their next papers. This is to make sure one discount for one paper only. If there is last paper the student has the option to get discount in CBT or in Tuition fee.
